## H.5 Update: Asphalt Road Construction Project

Knecht

- During this meeting, the letter from WSB was referenced. See item G in these minutes, "Letter from WSB, April 2, 2006 re: Update on [the four 2005 road improvement] projects."
- The Clerk was asked to determine the current status of invoices from WSB.
- Knecht said that WSB indicated to him that they anticipate completion of the four road improvement projects by the end of June; Knecht wants the work to be done by the end of May.
- The Board agreed that when the four 2005 road improvement projects are complete, they will consider any road improvement work required for Eaton Avenue. It is likely, Knecht observed, that any work required on that road, will be a 2007 project.

## H.6 Review: Township Insurance with K. McCullough

Knecht

Knecht said that he would invite Ms McCullough from MAT to assess the Township's coverage and to address her findings at a meeting of the Town Board.

H.7 <u>Update: Road Corridor Study</u>

Knecht

It was observed at this meeting that the cost of such a study has been estimated to be \$400,000.00. Knecht said that he is seeking ways to limit the scope of the study so that it can be done at an affordable price. Ebling is the point person to pursue this possibility.

H.8 <u>Update: 115<sup>th</sup> Street (No access to 115<sup>th</sup> Street from Bridgewater Heights)</u>
Knecht observed that more dirt was moved during last summer on this road than the Supervisors had anticipated. Knecht said that his position is that no traffic can either exit or enter Bridgewater Heights from 115<sup>th</sup>
Street until the road is blacktopped. Resident Bruce Morlan suggested that fixing the hill should also be a necessary condition.

H.9 Report: from Bridgewater Township Dundas Planning Commission Members

Bruce Morlan reviewed the Dundas Capital Improvements Plan, focusing on Bridgewater Heights, Stoneridge, and the new College City Beverage location.

Morlan briefly spoke about the controversy about maintaining both crop and wet land. Ebling observed Dakota County's initiatives in this matter.

Morlan spoke about low density housing zones, compost sites in housing developments and the use of wind power.

## I.2 Report on Road Grading

Knecht/Ebling

There was some discussion whether gravel or rock or a mix of the two is the best for the Township's roads. The matter will be further reviewed; Knecht indicated that he would speak with Blair Fowler about the matter. Two bids were received from gravel companies. The Township anticipates spending approximately \$80,000 on gravel and/or rock this year. Ebling raised the possibility of using "CBR Plus" on our gravel roads.

#### Motion re Purchase of Road Material

It was moved that the Town Board will make a decision about what kind of material to purchase and from whom after the Spring Road Tour, scheduled for April 21, 2006 and a visit to the two bidding vendors. Motion by Knecht, second by Ebling, motion passed unanimously (Doran-Norton aye, Ebling aye, and Knecht aye).

# I.5 <u>Potential Northfield Infrastructure Extensions by Heidi Hamilton, City</u> of Northfield Engineer

Hamillton

Heidi Hamilton, Northfield City Engineer, indicated that the search for an alternate site for College City Beverage lead the City of Northfield to investigate a site west of the Northfield Hospital. The site originally investigated is presently on hold due to the cost of installing water and sewer infrastructure. The present possibility being investigated is east of Decker, south of Minnesota 19, and north of 100<sup>th</sup> Street.

During discussions about the new possibility, it was noted that there are 2 creek basins in the area that will be an environmental concern. It was also noted by the Supervisors that a railroad spur in the area would be helpful.
